



LIFETIME LIMITED LABOR WARRANTY

Warranty: This limited labor warranty applies to all products purchased by the original Owner from Improveit! Home Remodeling. Improveit! Home Remodeling warrants to the Owner that (1) the installation work performed by Improveit! Home Remodeling will be free of defects due to workmanship for as long as Owner owns and resides in the home where Improveit! Home Remodeling performed the installation, subject to the other terms and conditions contained in this warranty and (2) Improveit! Home Remodeling will provide all labor at no cost to the Owner to repair or replace any product purchased by Owner from Improveit! Home Remodeling that is deemed defective by the manufacturer of such product under such manufacturer's warranty, subject to the other terms and conditions contained in this warranty. Any election to repair or replace shall be solely within the discretion of Improveit! Home Remodeling and the manufacturer. Parts and materials required under this warranty may be provided by the manufacturer. Please review any manufacturer's warranties provided to you for terms of coverage under those warranties.

Warranty Claims: Owner may request service under this warranty by contacting Improveit! Home Remodeling at (614) 291-5400. A visual inspection by an authorized representative of Improveit! Home Remodeling may or may not be required.

What Is Not Covered: These warranties are granted by Improveit! Home Remodeling to the Owner only and only labor provided by Improveit! Home Remodeling is covered by these warranties. All warranties terminate immediately upon the transfer of home ownership. All warranties assume normal and reasonable use of installed products or components. Minor color or textural variations from lot-to-lot of products are not product defects. These warranties do not cover any other damage, workmanship, or material failure including, but not limited to, damage caused by occurrences beyond the control of Improveit! Home Remodeling, such as settlement of the building, failure of the structure (including foundations and walls), use of incompatible accessories, removal, repair, or re-installation of any manufacturer products or components by other than Improveit! Home Remodeling, normal weathering, corrosive effects of salt air and chemical pollutants, normal fading, deterioration of caulking compounds, fire, flood, lightning, high winds, windblown objects, earthquakes, hurricanes, ice dams, icicles and/or ice storms, atmospheric conditions or weather of catastrophic nature as defined by the United States National Weather Service, other acts of God, intentional acts, unreasonable use or failure to provide reasonable maintenance, or damage due to or arising from the identification, detection, abatement, encapsulation, or removal of mold, asbestos, lead-based products, or other hazardous substances inside or outside of the structure being improved. Caulking is not considered a part of the warranty and therefore is not covered by this warranty. Condensation on any window, door or other structure is the natural result of excessive moisture in the house, and does not indicate a defective product or faulty installation. Improveit! Home Remodeling is not responsible for condensation and this warranty does not apply to condensation, its causes or its effects. Improveit! Home Remodeling reserves the right to charge customers a trip charge of seventy-five dollars (\$75).
