LIMITED LIFETIME WARRANTY WINDOW AND SLIDING GLASS DOOR

Vinyl Kraft Windows and Doors (“Manufacturer”) provides this product warranty to you, the original consumer purchaser (“Owner”) for as long as you own and reside in the house in which The PERFORMAX54™ Window and/or Sliding Glass Door is installed (Owner’s “Lifetime”). This warranty is available for inspection prior to any purchase.

TRANSFERABLE LIMITED LIFETIME WARRANTY

Manufacturer extends the following warranties to Owner during Owner’s Lifetime:

- **Broken Glass:** The PERFORMAX54™ Window is warranted against accidental glass breakage.
- **Glass Seal Failure:** The sealed insulated glass unit of The PERFORMAX54™ Window is warranted against defects resulting in material obstruction of vision from film formation or moisture collection due to failure of the hermetic seal between the interior glass surfaces of the insulating unit.
- **Vinyl:** Vinyl on The PERFORMAX54™ Window is warranted against chipping, cracking, peeling, pitting, or blistering.
- **Screen:** Screens on The PERFORMAX54™ Window are warranted against manufacturing defects.
- **Parts:** Balances, clips, and locks on The PERFORMAX54™ Window are warranted against failure.

How to Obtain Warranty Service: While this warranty is offered by Vinyl Kraft Windows and Doors, to submit a claim, Owner must send a description of the claim to Manufacturer’s agent, Improveit! Home Remodeling 4580 Bridgeway Ave., Suite B, Columbus, Ohio 43219 or contact Improveit! Home Remodeling at 1-800-555-6125 or at www.improveitusa.com. Claims must be submitted to Improveit! Home Remodeling for processing with Manufacturer promptly after discovery of the claimed defect and within the applicable warranty period. Improveit! Home Remodeling will then schedule an appointment within a reasonable period of time after having received the claim to inspect the premises and the warranty claim on behalf of Manufacturer. If Manufacturer determines that a valid claim exists, Manufacturer shall have the right to substitute product(s) designated by Manufacturer to be of equal quality. Replacement of a product or component does not renew the warranty period. If, at Manufacturer’s option, a purchase price refund is conveyed to the Owner, then all warranties are terminated, and repair, replacement, or removal of Manufacturer’s products shall become the sole responsibility of the Owner. No warranties are valid unless and until the Owner has made full payment under the original sales contract for goods and services and all addenda thereto.

What Is Not Covered: All warranties terminate immediately upon the transfer of home ownership, unless the terms of transfer are met (see “How to Transfer This Warranty”). All warranties assume normal and reasonable use of installed products or components. Minor color or textural variations from lot-to-lot of product are not product or installation defects. This warranty does not cover any damage caused by occurrences beyond the control of Manufacturer, including, but not limited to, settlement of the structure, failure of the structure (including foundations and walls), use of incompatible accessories with Manufacturer products or components, removal, repair, or re-installation of any Manufacturer products or components by other than Improveit! Home Remodeling, normal weathering, corrosive effects of salt air and chemical pollutants, normal fading, deterioration of caulking compounds, fire, flood, lightning, high winds, windblown objects, earthquake, hurricanes, ice dams, icicles and/or ice storms, atmospheric conditions or weather of catastrophic nature as defined by the U.S. National

Caulking, coil, nails, screws, wood and trim are not considered parts of the window, and therefore are not covered by this warranty.

What Voids This Warranty: Installation, removal, painting, repair, adjustment, tampering, or re-installation of any Manufacturer products or components by other than Improveit! Home Remodeling voids any and all warranties within this document, and Manufacturer expressly disclaims any liability for any costs, defects, or damages with respect to such actions.

Remedies and Rights: This warranty is the only express warranty provided by Manufacturer. No employee, representative, agent, nor any other person, has authority to assume or incur on behalf of Manufacturer any obligation, liability, or responsibility in place of or in addition to this warranty. To transfer these warranties, the Owner must request by certified mail, within 15 days of sale of residence, an inspection and re-certification of The PERFORMAX54™ Window by Manufacturer's agent, Improveit! Home Remodeling, and upon inspection and re-certification to the satisfaction of Improveit! Home Remodeling or upon Improveit! Home Remodeling's waiver of such inspection and re-certification, these warranties shall transfer to the subsequent homeowner. No other or further transfers of these warranties are permitted.
